## The city of Westlake Village approves animal hospital and pet hotel



On Sept. 9, the Westlake Village City Council unanimously approved the development of a new luxury pet hotel and animal hospital at 31166 Via Colinas in Westlake Village.

The Barkley Pet Hotel and Day Spa is a luxury-style pet resort. Alongside the hotel will be Westlake Village Animal Hospital with two veterinary professionals.

The 18,600-square-foot pet hotel will combine amenities with recreational activity for pets. The Barkley will house about 200 dogs and 40 cats, along with special facilities for birds and exotic pets.

High-end luxury suites with flat-screen televisions, leather sofas and Web cam communication technology are available.

Pets exercise in adjacent outdoor play areas. A grooming spa and a pool are also available. The hotel will be a 24-hour facility.

The animal hospital is a 8,600-square-foot veterinary facility with Dr. Steven Rosenstein of Agoura-Westlake Animal Hospital and Dr. Daniel Slaton of Westlake Village Animal Hospital. The practice will provide both traditional medicine and state-of-the-art technology, allowing the doctors to perform orthopedic and soft tissue surgeries, digital X-ray and ultrasound, stem cell therapy, acupuncture, veterinary orthopedic manipulation and other holistic treatments.

The practice will offer 24hour on-call emergency service, pickup and delivery, and discounted vaccine and spay/neuter programs to assist those with special circumstances.

The pet hotel and animal hospital will be across the street from the Four Seasons Hotel. The projected opening date is April 10, 2010. The project expects to bring approximately 40 new jobs to the community when the hiring process begins in early 2010.


